5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any



impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

## **Comprehensive Maintenance of Photocopier**

### **General terms & conditions and job details:**

1. The duration of this Contract shall be for a period of Three (03) years with effect from the commencement of the contract, unless it is curtailed or terminated by the PSSCIVE, Bhopal owing to breach any terms and conditions of this tender/BID document. The rates shall remain constant & will not be subject to any variation during the currency of the contract.
2. **The Registered Office and Service Centre of the Service Provider should be located in Bhopal, Madhya Pradesh.**
3. Servicing includes viz. (a) electrical parts repair, (b) complete cleaning of the main parts of the machine, (c) making all essential adjustment inclusive of repairs and replacement of parts, if any, (d) movement order, etc., both mechanical and electrical.
4. There shall be 12 preventive servicing in a year strictly on monthly basis.
5. Each service will be supervised by In-charge AMC, C&W section of PSSCIVE. Service Report has to be submitted to the PSSCIVE on Monthly basis and bill has to submitted on quarterly basis for payment. Payment will be done on per page basis.
6. The date of servicing of the machine would be at the discretion of PSSCIVE. Contract includes cost of all spare parts and consumables, i.e., Toner & Drum required to run the copier in efficient manner.
7. If the contractor failed to attend the breakdown within 48 hours after communication by this Department telephonically and/or in writing, the department reserves the right to run the copier.
8. In the event of breakdown/or failure in machine after servicing, you representative would pay a visit to the I/c AMC as and when intimated and you shall have to attend this forth- with without any extra charges.
9. The three-year period of servicing will commence from the date of acceptance of contract by the department/after the expiry of current AMC, whichever is applicable.
10. **This office reserves right to terminate the contract at any time after giving a one month's notice to the selected bidder with or without assigning any reason and shall be under no obligation whatsoever to continue the contract.**
11. During the continuance of AMC, if the machine becomes obsolete/unserviceable, then the contract will be terminated in that month itself in which the machines become obsolete/unserviceable. The payment, therefore, will be made on pro-rata basis (proportionately)
12. During the course of servicing or repairing PSSCIVE shall not be liable for any damage or loss direct, indirect or consequential to any person or property/procurements of the servicing agency, as a result of operation/breakdown or accident of this machine or any other circumstances beyond the control of PSSCIVE.
13. In case of any dispute in the service contract, the decision of the Joint Director, PSSCIVE, Bhopal shall be final and binding on you.
14. GST as applicable may be mentioned.



**Additional conditions/requirements:**

1. The tender will be accepted by the competent authority in PSSCIVE as per the rules/instructions issued by the Government of India from time to time in the matter.
2. The prospective bidder is required to indicate its GST/Registration Number, whichever applicable. The same must be mentioned in its quotation and also in bill as and when it is submitted.
3. The Joint Director, PSSCIVE reserves the right to reject any or all tender/extend the date of opening of tender etc. without assigning any reasons thereof.
4. 5. All questions, disputes or differences arising in connection with the contract shall be subject to the exclusive jurisdiction or the courts at Bhopal.



**Scope of Work of photocopier**

Comprehensive AMC will cover Full Service Maintenance Agreement of the Multifunction Photocopier (drum, blade, toner cartridge etc.) and spare parts. Any defects reported in the photocopier machines must be repaired/replaced by the service provider at its own cost. Parts so replaced should be new and genuine OEM parts or as prescribed by OEM in their service manual. Comprehensive AMC would be for a period of three years.

The interested bidders should upload duly signed Bid along with scanned copies of all the relevant documents in support of their bids – all duly signed, on the GeM Portal within the stipulated last date of BID.

**Payment**
