2. Candidates must ensure that they fulfil the eligibility conditions in terms of educational qualification experience etc. At any stage, if it is found that any candidate is not fulfilling the eligibility conditions as mentioned in the advertisement. His/her candidature shall be rejected.
3. The candidates are advised to check the schedule of Skill Test/Walk-in-interview as per Annexure-I.
4. All eligible candidates are required to bring filled Application form along with recent passport size photographs affixed on it. All Original documents and a set of self-attested copies of marksheet etc is to be produced at the time of interview, mandatorily.
5. Interested candidates who fulfil the eligibility criteria may attend the walk-in interview on scheduled date and time at PSSCIVE, Shyamla Hills, Bhopal.
6. The posts are purely temporary and PSSCIVE reserves all rights whether to fill all the posts mentioned in the advertisement or not keeping in view the performance and suitability of the candidates appearing in the interview.
7. Candidates already employed shall have to produce "Relieving Certificate" at the time of joining in PSSCIVE.
8. No TA/DA will be paid for attending the skill test / walk-in-interview or joining the post.
9. The selected candidates will be required to join immediately.
10. Candidates should also bring along with their written and/or published work, if any (including their art work, multimedia, graphics, animation, audio/videos advertisement/promos, books, journals, thesis/ dissertation magazines, etc.) at the time of skill test/walk-in-interview.

18. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which it is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.
19. The interested and eligible candidates may apply in the prescribed format. Separate application may be filled, if applied, for more than one post.
20. Cut-off date for determining age limit in respect of all posts is 30/11/2024.
